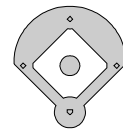

In consideration of payment to the Promoter by the Dealer for table rental at the Show, the parties hereto agree as follows:

- 1. The Dealer agrees to fulfill all municipal, city, state and federal requirements, if any, in connection with all sales made. The Dealer agrees to hold harmless the Promoter from any claims arising from violations thereof.**
- 2. The Dealer agrees to indemnify, protect and hold harmless J. Paul Sports Promotions, Inc., Robert Morris University, The Charles L. Sewall Center, their members, officers, employees, agents and representatives for any liability, personal injury, property loss, theft or damages of any nature suffered by any person as the result of the operation of the Show.**
- 3. The Dealer agrees to obey all rules of the Show premises and to abide by all local rules and regulations and ordinances. The Promoter reserves the right to restrict or refuse or expel at any time exhibits which in it's judgement may detract from the general character of the Show. This reservation includes persons, things, printed matter or anything of a character which might be objectionable or detrimental to the Show, including grab bags, dice games or any game of chance, as well as nude pictures or cards and unlicensed products.**
- 4. The Dealer understands that table locations will be processed on a first come-first served basis. Multiple table orders will receive preference when booking the same time as single table orders. The Promoter reserves the right to change table locations as it deems necessary.**
- 5. The Dealer agrees to remit a deposit of \$50.00 per table requested with this contract. The balance of payment to be received by the Promoter by April 18, 2012. If the balance is not received by April 18, 2012, the Promoter reserves the right to cancel this contract. Dealer deposits are non-refundable, but may be applied towards the next Pittsburgh J. Paul Sports Promotions show if tables are cancelled prior to May 4, 2012. Deposits and full payments for tables cancelled after May 4, 2012 are non-refundable and may not be applied toward future shows.**
- 6. The Promoter will provide guard(s) during and after Show exhibit hours, but without responsibility and/or liability to Dealers.**
- 7. All backup tables must be placed horizontally and not perpendicular to the tables contracted for. Only those dealers purchasing an end cap are permitted to have a perpendicular table which will be set up and skirted by the promoter prior to the start of the show.**
- 8. All tables, chairs, cases, Dealer merchandise, goods and equipment must be maintained within the confines of the table(s) contracted for.**
- 9. All Dealer merchandise, goods and equipment must be removed immediately following the closing of the last day of the show.**
- 10. In the event the premises are destroyed by fire or the elements, or by any other cause, or in case any circumstances whatsoever shall make it impossible for the Promoter to permit Dealers to occupy the premises, the Dealer shall pay for space on a pro-rata basis only for the period the space was occupied. The Promoter is released from any and all claims for damages which might arise from such consequences.**
- 11. Dealer breakdown begins at 4:00 PM on Sunday. Overhead doors and access to ramps will not be made available before then.**
- 12. If the Dealer fails to comply in any respect with the terms and conditions of this agreement, the Promoter shall have the right to terminate the contract and retain any and all payments made by the Dealer. In the event the Dealer fails to occupy said table, the Promoter is expressly authorized to occupy said space as it sees fit.**
- 13. Two Dealer badges per Dealer are included. Additional badges are available at \$10.00 each.**
